## Limited Warranty Terms

---

*The registration form on the preceding page is incorporated with the following limited warranty terms.*

### Coverage Period

Legendare Outdoors warrants to the original retail purchaser that each Legendare Outdoors No-Till Drill will be free from defects in material and workmanship under normal use, service, and maintenance for a period of two (2) years from the original date of retail purchase for personal, non-commercial use, and for a period of one (1) year from the original date of retail purchase for commercial or rental use.

### Who Is Covered

This Limited Warranty applies only to the original retail purchaser and is not transferable.

### Exclusive Remedy

Legendare Outdoors' sole obligation under this Limited Warranty, and the purchaser's exclusive remedy, shall be limited to the repair or replacement, at Legendare Outdoors' option, of any part determined by Legendare Outdoors to be defective in material or workmanship. Legendare Outdoors reserves the right to inspect any product or part claimed to be defective before approving any warranty claim.

### Exclusions

This Limited Warranty does not apply to any product or part that, in Legendare Outdoors' determination, has been subject to:

- misuse, abuse, neglect, or accident;
- improper operation, improper setup, improper calibration, or improper maintenance;
- repair, alteration, or modification not authorized by Legendare Outdoors;
- use for any purpose other than that for which the product was designed;
- damage resulting from improper storage, loading, transport, or handling; or
- normal wear and tear, including wear items and cosmetic deterioration, such as disc blades, seed tubes, chains, sprockets, closing wheels, coulters, paint, finish, and decals.

### How to Obtain Warranty Coverage

To obtain warranty coverage, the purchaser must notify the authorized Legendare Outdoors dealer that originally sold the product and provide proof of original purchase, product model, and serial number with any warranty claim. Any claimed defect must be reported promptly after discovery and within the applicable warranty period. All warranty claims and warranty adjustments must be processed through that dealer unless otherwise authorized in writing by Legendare Outdoors. No warranty repair work may be performed without prior written approval from Legendare Outdoors.

### If the Selling Dealer Is Unavailable

If the original selling dealer is no longer in business or is no longer authorized, the purchaser must contact Legendare Outdoors directly for claim instructions.

### **Labor and Replacement Parts**

Dealer labor for approved warranty repairs may be covered only if pre-authorized in writing by Legendare Outdoors. Travel time, service calls, pickup, delivery, and freight are not covered unless specifically authorized in writing by Legendare Outdoors. Any part repaired or replaced under this Limited Warranty shall be warranted only for the remainder of the original warranty period.

### **Design Changes**

Legendare Outdoors reserves the right to make design, material, or specification changes at any time without notice and without obligation to make similar changes to products previously manufactured or sold.

### **Additional Items Not Covered**

- transportation charges to or from the dealer or factory;
- travel time, service calls, pickup, or delivery charges from the dealer or factory; or
- loss of time, loss of use, loss of profits, loss of crops, harvest delays, rental equipment, labor, supplies, or any other incidental or consequential expense or damage.

### **Limitation of Liability**

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, LEGENDARE OUTDOORS SHALL NOT BE LIABLE FOR ANY INCIDENTAL, CONSEQUENTIAL, SPECIAL, INDIRECT, OR CONTINGENT DAMAGES ARISING OUT OF THE USE OF OR INABILITY TO USE THE PRODUCT, EVEN IF LEGENDARE OUTDOORS HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

### **Disclaimer of Other Warranties**

EXCEPT FOR THIS EXPRESS LIMITED WARRANTY, LEGENDARE OUTDOORS MAKES NO OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. TO THE EXTENT ANY IMPLIED WARRANTY CANNOT BE DISCLAIMED UNDER APPLICABLE LAW, SUCH IMPLIED WARRANTY IS LIMITED IN DURATION TO THE APPLICABLE EXPRESS WARRANTY PERIOD STATED ABOVE.

### **Registration Requirement**

This Limited Warranty is valid only if the product is registered with Legendare Outdoors within thirty (30) days of the original retail purchase date.

### **State Law Rights**
